Open Spaces Working Group Notes 30th January, 2025 at 6.15pm

Appointment of Chairman

Councillor Scarisbrick was appointed as Chairman for the meeting.

Jubilee Gardens Planting Scheme

Councillors considered a proposed planting scheme from Bleadon Horticultural Society. Councillors had previously identified the following requirements from any planting scheme:

- Drought tolerant plants
- Low height and low maintenance
- Year round colour
- Replacement of rose bushes with a dwarf tree/specimen plant
- Herbs along the front edge to provide smell and the opportunity for parishioners to use for culinary purposes
- Plants along the stone wall with root systems which would not damage the stone wall

Councillors considered that the scheme met all of these issues and welcomed the support of the BHS in developing the scheme and the offer to provide both practical and financial help in implementing the scheme. It was noted that Council had approved a budget of $\mathfrak{L}1,000$ in respect of a planting scheme and had delegated authority in relation to its implementation.

The Clerk was asked the pass the group's thanks to the BHS and to make arrangements to implement the scheme presented.

Play Equipment Feedback

18 responses had been received to the survey conducted through Parish News. One of these responses was a response from the youth club following a facilitated session conducted by the YMCA. Proposals in relation to swings, climbing net and a carousel were all extremely popular. Other suggestions received included a basketball hoop and a trampoline. Further work would now be undertaken as to how best to configure the existing site given the feedback received.

The proposals for gym equipment had also been well received. Two responses had suggested that the area would be better used for social gatherings. Councillors considered that there was merit in

exploring the provision of gym equipment further and to assess whether there might be external grant funding opportunities. The Clerk advised that – in general terms – grant applications were likely to be more successful where it could be demonstrated that the grant sought was a small part of a wider scheme i.e. the funding body was not being asked to fund the entirety of any works. There was a clear opportunity to set the gym proposals in the context of a wider scheme centred around physical improvements to the car park environs and bringing forward the refurbishment of the toilet block would be a key component. The Clerk was asked to investigate funding opportunities for gym equipment and identify a project plan/timescale for the refurbishment of the toilet block.

Planters/Tubs Required for 2025 planting scheme

Councillors favoured limited changes to the existing arrangements, noting that there were some tubs which had already been authorised for removal and some which would need replacing because they had deteriorated to a point where they could no longer be used. In such cases, councillors favoured using tractor tyres as replacement planters – tractor tyres reflecting the agricultural heritage of the Parish. It was recognised that these initial conclusions would need to be tested with the volunteers who undertake planting and watering. *The Clerk was asked to test these initial thoughts with volunteers and report back.*

Parish Clock Update

Councillors noted that Smiths of Derby had been contacted and were in the process of arranging an engineer to visit to try and establish why the clock mechanism was not functioning.

Tree Works

Councillors were updated on the procurement process which was underway, the results of which would be reported to the next meeting of Council.

Market/Village Cross Cleaning
